Website Privacy Policy

- 1.1. This privacy policy sets out how DCFX PRIME PTE. LTD. ("DCFX") uses the personally identifiable information (the "Personally Identifiable Information") that it collects.

- 1.3. Please note that if you apply for an account with us then DCFX will ask you for detailed information. DCFX shall use that information in the ways agreed between you and us as set out in the Terms of Business and application form.

Security

- 1.5. DCFX are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure, have put in place suitable physical, electronic and security procedures to safeguard and secure the information DCFX collects online.

Cookies

- 1.6. A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.
- 1.7. DCFX uses traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. DCFX only uses this information for statistical analysis purposes and then the data is removed from the system.
- 1.8. Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
- 1.9. DCFX may set and access DCFX cookies on your computer. You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. However, this may prevent you from taking full advantage of certain website features (i.e. customised information).
